PROVISIONAL AGREEMENT BETWEEN GREAT BRITAIN AND SERVIA RESPECTING COMMERCIAL RELATIONS.

Signed at Belgrade, July 4, 1893.

THE Government of Her Majesty the Queen of the United Kingdom of Great Britain and Ireland, Empress of India, and the Government of His Majesty the King of Servia, desiring to regulate provisionally, during the time necessary for the conclusion and the ratifications of a Treaty of Commerce, the commercial relations between the two States, have agreed upon the following provisions:—

ARTICLE I.

The subjects, ships, and goods produce or manufacture of the two countries, shall respectively enjoy, in all respects, the treatment of the most favoured nation.

ARTICLE II.

This Agreement shall come into force the day after that on which it shall have received the approval of the Servian National Assembly. It shall remain in force until the ratifications of the Definitive Treaty of Commerce shall have been exchanged, but, in any case, its effect shall cease on the ^{1st} January, 1894.

LE Gouvernement de Sa Majesté la Reine du Royaume-Uni de la Grande-Bretagne et d'Irlande, Impératrice des Indes, et le Gouvernement de Sa Majesté le Roi de Serbie, désirant régler provisoirement, pendant le temps nécessaire pour la conclusion et les ratifications d'un Traité de Commerce, les rapports commerciaux entre les deux États, sont convenus des dispositions suivantes:—

ARTICLE I.

Les sujets, les navires, et les produits de toute nature originaires des deux pays, jouiront respectivement et sous tous les rapports, du traitement de la nation la plus favorisée.

ARTICLE II.

Cette entente sera exécutoire le lendemain du jour où elle aura reçu l'approbation de la Skoupchtna Nationale de Serbie. Elle restera en vigueur jusqu'à ce que les ratifications du Traité de Commerce Définitif aient été échangées, mais en tous les cas elle cessera ses effets le ^{1^{er}} Janvier, 1894.
