M. Carlin to Sir Edward Grey.—(Received June 19.)

M. le Secrétaire d'État, *Londres, le 18 juin, 1906.*
SUR l'ordre de mon Gouvernement, j'ai l'honneur d'informer votre Excellence que, par note du 7 courant, le consulat-général de Colombie à Genève a notifié au Conseil fédéral suisse l'accession de la République de Colombie à la convention conclue à Genève, le 22 août, 1864, pour l'amélioration du sort des militaires blessés dans les armées en campagne.
