Your Excellency,

I HAVE the honour, in accordance with instructions received, to approach your Excellency in the following matter:—

In the Annex of the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Netherlands for Certain Air Services, concluded in London on 13th August, 1946,⁽¹⁾ it is stated that the schedules mentioned therein may be revised from time to time by agreement between the competent aeronautical authorities of the Contracting Parties.

In connexion herewith, it is proposed by the Netherlands Aeronautical Authorities that there be added to Schedule IV of the Annex, which stipulates the Netherlands routes traversing British territory, a route Amsterdam-Manchester-Dublin.

As it is understood that the British Aeronautical Authorities agree to this proposal, I have been instructed to request your Excellency to be good enough to cause the necessary steps to be taken to have the above-mentioned route included as Sub. 5 in Schedule IV of the Annex to the Agreement.
