*Mr. Ernest Bevin to M. René Massigli*

Your Excellency,

*18th June, 1947*

I HAVE the honour to inform you that His Majesty's Government in the United Kingdom propose that the provisions of the Air Transit Agreement signed at Chicago on the 6th December, 1944<sup>(1)</sup>, shall be considered to be in force as from to-day's date between the French Government and His Majesty's Government on the understanding that the exercise of the rights thereby accorded will be subject to the general provisions of the Anglo-French Civil Aviation Agreement of the 28th February, 1946<sup>(2)</sup>, and in particular of Article II thereof, and that, in addition, the competent aeronautical authorities of the two countries will notify each other of the effective opening of each service operated by their carriers and crossing their respective air space.

2. If this proposal is agreeable to your Excellency's Government, I have to suggest that the present note and your reply in the same terms shall be considered as constituting an agreement between our two Governments to this effect which shall remain in force until twelve months from the date on which either party has given notice of termination to the other.

VOTRE Excellence a bien voulu m'adresser en date de ce jour la lettre dont la teneur suit :

" M. l'Ambassadeur,

" J'ai l'honneur de vous faire savoir que le Gouvernement de Sa Majesté dans le Royaume-Uni propose de considérer les dispositions de l'Accord sur le Transit des Services Aériens Internationaux signé à Chicago le 6 décembre 1944 comme en vigueur à partir de la date de ce jour, entre le

Gouvernement de la République Française et le Gouvernement de Sa Majesté, étant entendu que l'exercice des droits ainsi reconnus sera soumis aux dispositions générales de l'Accord aérien franco-britannique du 28 février 1946, et notamment de son article II, et que, d'autre part, les autorités aéronautiques compétentes des deux pays s'informeront mutuellement de l'ouverture effective de chaque service exploité par leurs entreprises et traversant l'espace aérien de chacun d'eux.

"Si cette proposition reçoit l'approbation du Gouvernement de votre Excellence, j'ai l'honneur de suggérer que la présente lettre et la réponse de votre Excellence dans les mêmes termes soient considérées comme constituant entre nos deux Gouvernements un accord à cet effet qui demeurera en vigueur jusqu'à ce qu'une des deux parties notify à l'autre, avec un préavis de douze mois, son intention d'y mettre fin.

"Veuillez agréer, &c."
