MONETARY AGREEMENT BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE ROYAL NORWEGIAN GOVERNMENT SUPPLEMENTARY TO THE MONETARY AGREEMENT OF 8th NOVEMBER, 1945

London, 31st March, 1949

The Government of the United Kingdom of Great Britain and Northern

Ireland and the Royal Norwegian Government,

Desiring to modify the arrangements resulting from the Agreement signed in London on 9th July, 1948,(1) Supplementary to the Monetary Agreement of 8th November, 1945(2) (hereinafter referred to as the "Supplementary Agreement"),

Have agreed as follows:--

ARTICLE 1

The Bank of England (acting as Agents of the Government of the United Kingdom) and the Norges Bank (acting as Agents of the Government of Norway) shall not exercise the right to require settlement in gold under the provisions of Article 1 of the Supplementary Agreement.

ARTICLE 2

The present Agreement shall come into force on this day's date. It shall remain in force until the termination of the Supplementary Agreement.

In witness whereof, the undersigned, duly authorised by their respective Governments, have signed the present Agreement and have affixed thereto their seals.

Done in London, in duplicate, the 31st day of March, 1949.
