Your Excellency,

Madrid, 6th April, 1949.

I have the honour to propose to your Excellency, under instructions from His Majesty's Principal Secretary of State for Foreign Affairs, that the Agreement relating to Trade and Payments signed at Madrid on 23rd June, 1948.⁽¹⁾ between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Spanish State, which, under Article III thereof, is due to terminate on 7th April, 1949, unless the Contracting Governments agree otherwise, shall be extended from the latter date until 30th June, 1950.

2. If the Spanish Government agree to the above proposal, I have the honour to suggest that the present Note and your Excellency's reply in that sense shall be regarded as constituting an Agreement between the two Governments in this matter.
