British Embassy,

Your Excellency,

Buenos Aires, July 11, 1955.

I have the honour to refer to discussions which, in accordance with Article 21 of the Agreement on Trade and Payments between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Argentine Republic, signed on the 31st of March, 1955,⁽¹⁾ have taken place between the representatives of the two Governments to the Mixed Consultative Committee in order to agree on products to be exchanged during the second year of the Agreement.

2. I have pleasure in conveying to your Excellency the agreement of my Government to regard the estimates of imports of goods contained in Schedules A, B and C to the Agreement as valid for second year thereof (from the 1st of July, 1955, to the 30th of June, 1956).

3. In informing your Excellency that the present Note together with a favourable reply from your Excellency will be considered by my Government as effectively confirming the Agreement reached between our two Governments,

Tengo el honor de dirigirme a vuestra Excelencia con el objeto de acusar recibo de su Nota del día de la fecha, cuyo texto traducido, dice:

“ Señor Ministro:

“ Tengo el honor de dirigirme a vuestra Excelencia con referencia a las conversaciones que, de conformidad a lo establecido en el Artículo 21º del Convenio Comercial y de Pagos firmado el 31 de marzo de 1955 entre el Gobierno del Reino Unido de Gran Bretaña e Irlanda del Norte y el Gobierno de la República Argentina, han sido mantenidas entre los

representantes de ambos Gobiernos, en la Comisión Mixta Británica-Argentina, a fin de llegar a un acuerdo sobre los productos a ser intercambiados durante el segundo año vigencia de dicho Convenio."

"Al respecto me complazco en comunicar a vuestra Excelencia que mi Gobierno está de acuerdo con respecto a las estimaciones de importaciones de mercaderías que se encuentran en las Listas 'A,' 'B' y 'C' anexas al mencionado instrumento, considerándolas válidas para el segundo año de vigencia del mismo (del 1º de julio de 1955 al 30 de junio de 1956)."

"Al informar a vuestra Excelencia que la presente Nota junto con la respuesta favorable a los términos expresados en la misma serán consideradas por mi Gobierno como confirmando efectivamente el acuerdo a que han llegado nuestros dos Gobiernos, aprovecho, etc.
