AGREED MINUTE RELATING TO THE EXCHANGE OF NOTES BETWEEN THE GOVERNMENT OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE REPUBLIC OF TURKEY OF DECEMBER 9, 1960

Discussions have been held in Ankara in accordance with paragraph (d) of the Notes exchanged between the Government of Great Britain and Northern Ireland and the Government of the Republic of Turkey on December 9, 1960(1). As a result of these discussions, Her Majesty's Government and the Turkish Government agree that the Agreement constituted by that Exchange of Notes shall be extended for a period of six months, ending on December 1, 1961 and that for this purpose the date "the 1st of June, 1961" in paragraphs (a), (b), (c) and (d) of the Notes should be amended to read "the 1st of December, 1961". Further discussions on the matters mentioned in paragraphs (c) and (d) shall take place before December 1, 1961. It is further agreed, with reference to paragraph (c) of the Notes, that a sum of 300,000 Turkish liras will be released immediately for expenditure on a British Pavilion at the Izmir Fair, which is one of the projects described in that paragraph,

BÜYÜK BRITANYA VE ŞIMALI IRLANDA HÜKÛMETI ILE TÜRKIYE CÜMHURIYETI HÜKÛMETI ARASINDAKI 9 ARALIK 1960 TARIHLI NOTA TEATISIYLE ILGILI OLARAK MUTABIK KALINAN HUSUSLARA ALAIR TUTANAK

Büyük Britanya ve Şimali İrlanda Hükûmeti ile Türkiye Cümhuriyeti Hükûmeti arasında 9 Aralık 1960 tarihinde teati edilen Notaların (d) fıkrasına müsteniden Ankarada cereyan eden müzakereler neticesinde, Majestelerinin Hükûmeti ile Türk Hükûmeti, Nota teatisi suretiyle varılmış olan Anlaşmanın 1 Aralık 1961 tarihinde nihayete ermek üzere altı aylık bir devre için temdidi ve bu maksatla Notaların (a), (b), (c) ve (d) fıkralarındaki "1 Haziran 1961" tarihinin "1 Aralık 1961" olarak değiştirilmesi hususunda mutabaktırlar. (c) ve (d) fıkralarında zikredilen mevzular 1 Aralık 1961 tarihinden evvel yeniden müzakere edilecektir. Teati olunan Notaların (c) fıkrasında tarif edilen projelerden biri olan İzmir Fuarında bir Britanya pavyonu için yapılacak masraflar dolayısıyla lüzumlu 300.000 Türk lirasının da derhal serbest bırakılması hususunda ayrıca mutabık kalınmıştır.
