EXCHANGE OF NOTES BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE UNITED STATES OF AMERICA CONCERNING AIR ROUTES BETWEEN THE WEST INDIES AND THE UNITED STATES

The United States Secretary of State to Her Majesty's Ambassador at Washington

Department of State,

Washington, November 22, 1961.

Excellency :

I have the honor to refer to the discussions which took place in London in June of this year between representatives of the United States of America and of the United Kingdom of Great Britain and Northern Ireland concerning air routes between the West Indies and the United States.

As a result of these discussions, I now am pleased to propose the following exchange of routes :

(i) For the United States :

<i>Points of Departure</i>	<i>Intermediate Points</i>	<i>Destination in United Kingdom Territory</i>	<i>Points Beyond</i>
1. New York	—	Jamaica	—
2. Atlanta	—	Jamaica	—

(ii) For the United Kingdom :

<i>Points of Departure</i>	<i>Intermediate Points</i>	<i>Destination in United States Territory</i>	<i>Points Beyond</i>
Antigua	—	New York	—

I further propose that :

- (i) the present agreement should terminate on October 1, 1962, unless extended by further agreement; and
- (ii) operations over the aforementioned routes should be in accordance with the provisions of the agreement between the Government of the United States of America and the Government of the United Kingdom of Great Britain and Northern Ireland relating to air services between their respective territories, signed at Bermuda on February 11, 1946⁽¹⁾, as subsequently amended.

If the Government of the United Kingdom of Great Britain and Northern Ireland is agreeable to the foregoing proposals, I propose that this note and your reply to that effect shall constitute an agreement between the two Governments in this matter which shall enter into force on the date of your note in reply.
