### **EXCHANGES OF NOTES**

CONCERNING THE CONSOLIDATION AND MODIFICATION OF FINANCIAL AGREEMENTS AND ARRANGEMENTS BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE HASHEMITE KINGDOM OF JORDAN

No. 1113/67 Your Excellency. British Embassy,

Amman, 2 May, 1967.

I have the honour to refer to our recent discussions concerning the consolidation of financial agreements and arrangements between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Hashemite Kingdom of Jordan for the modification of the obligations of the Hashemite Kingdom of Jordan arising from certain of these agreements.

Upon instructions from Her Majesty's Principal Secretary of State for Foreign Affairs, I now have the honour to propose to Your Excellency the following terms:

- (1) The provisions regarding repayment by the Hashemite Kingdom of Jordan which are set out in the agreements and arrangements listed in the Annex to this Note shall be terminated and shall be replaced by the provisions of paragraph (2) of this Note.
- (2) The Government of the Hashemite Kingdom of Jordan shall repay to the Government of the United Kingdom, in pounds sterling in London, in addition to the sum of £133,333 already repaid in January, 1958, the sum of £12,766,666 in forty-five equal half-yearly instalments of £277,500 payable each April and October beginning on the 1st of April, 1973 and one instalment of £279,166 payable on the 1st of October, 1995.
- (3) The provisions regarding payment by the Hashemite Kingdom of Jordan which are set out in sub-paragraph (xi) and in the Annex to the Exchange of Notes of the 13th of March, 1957(1), terminating the Treaty of Alliance of the 15th of March, 1948(2), and in sub-paragraph (ii) of the Exchange of Notes of the 13th of March, 1957, regarding the sale of ammunition, shall be terminated.

(4) The Government of the Hashemite Kingdom of Jordan shall not be obliged to make any further direct payments under the provisions of Article 11 (ii) of the Agreement of the 1st of May, 1951(3), for the settlement of Financial Matters outstanding as a result of the Termination of the Mandate for Palestine. The proviso to Article 11 (relating to the rights of the Government of the United Kingdom in relation to the surplus assets of the Palestine Currency Board), shall however not be affected by the above revision of the provisions of the Article.

If the foregoing proposals are acceptable to the Government of the Hashemite Kingdom of Jordan, I have the honour to suggest that the present Note and Your Excellency's reply in that sense should be regarded as constituting an agreement between the two Governments in this matter, which shall enter into force on to-day's date.
