#### **EXCHANGE OF NOTES**

BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM
OF GREAT BRITAIN AND NORTHERN IRELAND AND THE
GOVERNMENT OF THE FEDERAL REPUBLIC OF CAMEROON
CONCERNING AN INTEREST-FREE LOAN TOWARDS
THE COST OF MODERNISING THE CAMEROON
TÉLECOMMUNICATION SYSTEM

Her Majesty's Ambassador at Yaoundé to the Minister of Finance of Cameroon

(10411/67) Your Excellency, British Embassy, Yaoundé, 16 June, 1967.

I have the honour to refer to the recent discussions concerning development aid from the Government of the United Kingdom of Great Britain and Northern Ireland to the Government of the Federal Republic of Cameroon and to inform Your Excellency that the Government of the United Kingdom are prepared to conclude an Agreement with the Cameroon Government in the following terms:

- (1) The Government of the United Kingdom, acting by the Ministry of Overseas Development (hereinafter referred to as "the Ministry"), shall provide finance to the Government of Cameroon by way of an interest-free loan amounting to £350,000 (three hundred and fifty thousand pounds sterling) towards the cost of the modernisation of the Cameroon telecommunications system.
- (2) The Government of the United Kingdom shall adopt the procedure described in the following paragraphs of this Note in so far as it relates to things to be done by or on behalf of that Government. The Government of Cameroon shall adopt the procedure so described in so far as it relates to things to be done by or on behalf of that Government.
- (3) The Government of Cameroon shall, by a request in the form set out in Annex A to this Note, open a special account (hereinafter referred to as "the Account") with the Crown Agents for Oversea Governments and Administrations, 4 Millbank, London, S.W.1 (hereinafter referred to as "the Crown Agents"). The Account shall be operated in accordance with the instructions contained in the said request.
- (4) Unless and to the extent only that the Ministry otherwise agree in writing, the Account will be used only:
  - (a) for payments to a Contractor due under a contract for the modernisation of the Cameroon telecommunications system which:
    - (i) provides for payment in sterling to persons carrying on business in the United Kingdom, the Channel Islands or the Isle of Man:

- (ii) is a contract entered into after the date of this Note and before the 31st March, 1968; and
- (iii) is such a contract for the purchase of goods wholly produced or manufactured in the United Kingdom, the Channel Islands or the Isle of Man, or for work to be done or services to be rendered by persons ordinarily resident or carrying on business in the United Kingdom, the Channel Islands or the Isle of Man, as the Government of Cameroon and the Ministry may from time to time approve, being a contract awarded by the Crown Agents on behalf of the Government of Cameroon:
- (b) for payment of charges and commissions due to the Crown Agents in respect of their services in connection with this loan.
- (5) The Crown Agents acting on behalf of the Government of Cameroon shall as soon as possible forward to the Ministry in the case of each contract in respect of which it wishes payments to be made from the Account:
  - (a) a copy of the contract, or of a notification in the form set out in Annex B to this Note; and
  - (b) two copies of a certificate from the contractor concerned in the form set out in Annex C to this Note.

The Crown Agents shall inform the Ministry if at any time a contract (being a contract in respect of which such documents have been forwarded and in respect of which approval has been given or is pending) is amended or if liability is incurred or is to be incurred thereunder to a greater or lesser amount than the amount specified in the contract certificate, and in either of these cases the Crown Agents shall as soon as possible forward to the Ministry the relevant supplementary or revised documents.

(6) After the Ministry has considered the documents forwarded, in respect of any contract, by the Crown Agents in pursuance of the procedure described in the foregoing provisions of this Note and any additional information which it may request from the Government of Cameroon (or the Crown Agents) for this purpose (and which that Government (or the Crown Agents) will then supply), the Ministry shall notify the Crown Agents in the form set out in Annex C (i) to this Note whether and to what extent it approves the contract for the purposes of the loan and agrees that payments may accordingly be made from the Account. To the extent that the Ministry so approves a contract it shall, on receipt of a request from the Crown Agents acting on behalf of the Government of Cameroon, in the form set out in Annex C (ii) to this Note, giving details of contractual payments due and about to be made, make payments in sterling into the Account and each such payment shall constitute a drawing on the loan. The Ministry shall not make payments into the Account after the 31st March, 1969.

- (7) Withdrawals from the Account shall be made only in respect of the payments referred to in sub-paragraph (4) above and in the manner and subject to the conditions hereafter set out in this sub-paragraph:
  - (a) Withdrawals shall be made in accordance with Payment Authorities in the form shown in Annex D hereto duly signed on behalf of the Government of Cameroon and forwarded to the Ministry for counter-signature and accompanied by:
    - (i) for payments under sub-paragraph 4(a) above, a Payment Certificate from the Contractor in the form shown in Annex E hereto and the invoices (or photocopies or duplicates of such invoices) referred to therein;
    - (ii) for payments under sub-paragraph 4 (b) above, a copy of the invoices from the Crown Agents.

If the Ministry is satisfied on perusal of the invoices and Certificates that the payments listed on the Payments Authority are chargeable to the Account, the Ministry shall countersign the Payment Authority and forward it to the Crown Agents.

- (b) The amount of payment in respect of any one contract shall not exceed the amount specified in relation to that contract in the notification in the form set out in Annex C (i).
- (8) Before the first document is forwarded to the Ministry in accordance with sub-paragraph (5) above the Government of Cameroon shall furnish the Ministry with a copy of the Government's instructions to the Crown Agents given in accordance with sub-paragraph (3) above to open and operate the Account; and also notify the Ministry of the names of the officers who are duly authorised to sign the Payment Authorities on its behalf and furnish a specimen signature in duplicate of each such officer.
- (9) If any monies that have been paid out of the Account are subsequently refunded either by the contractor or by a guarantor the Government of Cameroon shall pay into the Account a sum equal to the monies so refunded.
- (10) The Crown Agents shall forward monthly to the Ministry a statement of receipts to and payments from the Account.
- (11) The Government of Cameroon shall repay to the Ministry in pounds sterling the total sum borrowed as envisaged by this Note, such repayments to be made by instalments paid on the dates specified below and amounting to the sums respectively specified in relation to those dates, so, however, that if, on the date when any such instalment is due to be paid, there is then outstanding less than the amount specified in relation to that date only the amount then outstanding will be paid:

- (12) Notwithstanding the provisions of sub-paragraph (11) of this Note, the Government of Cameroon shall be free at any time to repay to the Ministry in pounds sterling the whole or any part of the loan that is still outstanding.
- (13) Except as may be provided otherwise in this Note, the work of installing in Cameroon the goods supplied in accordance with the procedure described above shall be executed in conformity with the law of the Federal Republic of Cameroon.
- 2. If the foregoing proposals are acceptable to the Government of the Federal Republic of Cameroon, I have the honour to suggest that the present Note together with Your Excellency's reply in that sense shall constitute an Agreement between the two Governments which shall enter into force on the date of your reply and it shall be known as the United Kingdom/Cameroon Loan 1967.

I avail myself of this opportunity to renew to Your Excellency the assurances of my highest consideration.

## United Kingdom/Cameroon Loan, 1967

Dear Sir,

I confirm your appointment as agents of the Government of Cameroon (hereinafter called "the Government") in connection with the purchase and payment for goods, works and/or services under the terms of the above loan to the value of £350,000 (three hundred and fifty thousand pounds sterling).

- 3. Payments into the Account will be made from time to time by the Ministry of Overseas Development of Her Majesty's Government in the United Kingdom of Great Britain and Northern Ireland (hereinafter called "the Ministry") on receipt by the Ministry of requests in the form shown in Annex C(ii) to the United Kingdom/Cameroon Loan Agreement 1967 (a copy of which is attached hereto) and which you are hereby authorised to present on behalf of the Government. It is possible that, as a result of refunds becoming due from contractors, payments into the Account will also be made by the Government itself.
- 4. Payments from the Account are to be made only in respect of the amounts falling due under the contracts described in sub-paragraph (4) of the above-mentioned Agreement and in the manner and subject to the conditions described in sub-paragraph (7) of that Agreement.
- 5. You will supply the Ministry as soon as possible with a copy of any contract or notification of contract and of any amendment thereto as provided in sub-paragraph (5) of the said Agreement. You will also supply the Ministry with any additional information that it may require to enable it to satisfy itself that payments due under a contract may properly be debited to the Account.
- 6. You are to send to the Ministry at the end of each month a detailed statement showing all debits and credits to the Account during the month.
- 7. You are to send to the Ministry specimen signatures of the officers of the Crown Agents authorised to sign Payment Authorities on behalf of the Government.

- 8. Specimen signatures of the officers authorised to countersign Payment Authorities on behalf of the Ministry will be sent to you direct.
- 9. Your charges and commissions for acting as our agents in connection with this loan shall be chargeable to the Account.
  - 10. A copy of this letter has been sent to the Ministry.
