# CONCERNING AN INTEREST-FREE DEVELOPMENT LOAN BY THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND TO THE HASHEMITE KINGDOM OF JORDAN DURING THE FINANCIAL YEAR ENDING 31 MARCH 1968

Her Majesty's Ambassador at Amman to the Prime Minister of the Hashemite Kingdom of Jordan

British Embassy,

Your Excellency,

Amman, 9 August, 1967.

I have the honour to refer to our recent discussions concerning development aid from the Government of the United Kingdom of Great Britain and Northern Ireland to the Government of the Hashemite Kingdom of Jordan and to inform Your Excellency that the Government of the United Kingdom are prepared to conclude an Agreement with the Government of Jordan in the following terms:

- (1) The Government of the United Kingdom shall provide finance for the Government of Jordan by way of an interest-free loan amounting to £900,000 (nine hundred thousand pounds) sterling during the United Kingdom financial year ending on 31st of March, 1968, to be made available towards the execution of projects among the following:
  - (a) the construction of the Shueib and Kafrein Dams;
  - (b) irrigation in the Wadi Dhuleil;
  - (c) hydrological support for the Natural Resources Authority;
  - (d) any other projects to be agreed between the two governments.
- (2) Payments from this loan shall be made in advance in instalments agreed between the two governments in Notes which will specify the allocations to be made in respect of individual projects.
- (3) The total amount made available under the loan shall be repaid by the Government of Jordan to the Government of the United Kingdom in pounds sterling, such repayment to be made by instalments paid on the dates specified below and amounting to the sums respectively specified in relation to these dates.

- (4) Notwithstanding the provisions of sub-paragraph (3) above the Government of Jordan shall be free at any time to repay to the Government of the United Kingdom in pounds sterling the whole or any part of the loan that is still outstanding.
- 2. If the foregoing proposals are acceptable to the Government of the Hashemite Kingdom of Jordan, I have the honour to suggest that the present Note and Your Excellency's reply in that sense should be regarded as constituting an agreement between the two Governments in this matter.

Please accept, Your Excellency, the assurances of my highest consideration.
