AMENDMENT TO THE AGREEMENT BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE UNITED STATES OF AMERICA FOR COOPERATION ON THE USES OF ATOMIC ENERGY FOR MUTUAL DEFENSE PURPOSES OF JULY 3, 1958

The Government of the United Kingdom of Great Britain and Northern Ireland on its own behalf and on behalf of the United Kingdom Atomic Energy Authority and the Government of the United States of America;

Desiring to amend in certain respects the Agreement for Cooperation on the Uses of Atomic Energy for Mutual Defense Purposes, signed at Washington on the third day of July 1958(1), as amended(2);

Have agreed as follows:

ARTICLE 1

Article III bis of the Agreement for Cooperation shall be amended as follows:

The words "December 31, 1969" in paragraphs A and C thereof shall be deleted and the words "December 31, 1974" shall be substituted therefor.

ARTICLE 2

This Amendment, which shall be regarded as an integral part of the Agreement for Cooperation, shall enter into force on the date on which each Government shall have received from the other Government written notification that it has complied with all statutory and constitutional requirements for the entry into force of this Amendment.(3)

IN WITNESS WHEREOF, the undersigned, duly authorized, have signed this Amendment.
