EXCHANGE OF NOTES

BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE SOCIALIST FEDERAL REPUBLIC OF YUGOSLAVIA FURTHER REVISING THE ANNEX TO THE AGREEMENT CONCERNING AIR SERVICES SIGNED AT LONDON ON 3 FEBRUARY 1959.

Her Majesty's Embassy at Belgrade to the Secretariat of State for Foreign Affairs of Yugoslavia

Her Britannic Majesty's Embassy present their compliments to the Secretariat of State for Foreign Affairs of the Socialist Federal Republic of Yugoslavia and have the honour to refer to the recent correspondence which has taken place between the aeronautical authorities of the United Kingdom of Great Britain and Northern Ireland and of the Socialist Federal Republic of Yugoslavia regarding the amendment of the Annex to the Agreement concerning Air Services, signed at London on 3 February, 1959(1), as amended by the Exchange of Notes of 7 May/13 September, 1965(2) and 21 February/4 March, 1968(3). In this correspondence the aeronautical authorities have agreed in principle to the substitution of Sofia for Istanbul in route 2 of the routes to be operated by the designated airline or airlines of the United Kingdom as specified in the Annex.

The Embassy now have the honour to inform the Secretariat of State for Foreign Affairs that the Government of the United Kingdom approve the amendment referred to above and accordingly propose, on instructions from Her Majesty's Principal Secretary of State for Foreign and Commonwealth Affairs, that the Annex to the Agreement shall be amended as follows in accordance with Article 15 (2) of the Agreement:

In the English text: In Section 1, Route 2, Column 3, delete "Istanbul" and insert "Sofia".

In the Serbo-Croat text: In Odeljak 1, Linija 2, Rubrika 3, delete "Istanbul" and insert "Sofija".

If the foregoing is acceptable to the Government of the Socialist Federal Republic of Yugoslavia, the Embassy have the honour to propose that the present Note and the reply of the Secretariat of State for Foreign Affairs to that effect shall constitute an Agreement between the two Governments in this matter which shall enter into force on the date of the Secretariat's reply.

Her Britannic Majesty's Embassy avail themselves of this opportunity to renew to the Secretariat of State for Foreign Affairs the assurance of their highest consideration.
