Your Excellency,

*27 September, 1969.*

On the 31st of March, 1969, Your Excellency and I exchanged Notes<sup>(1)</sup> prolonging until the 27th of September, 1969, the current Agreement on Trade and Payments between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of Paraguay.<sup>(2)</sup>

2. Since the terminal date of that extension is now at hand, and negotiations for a new Agreement have not yet been completed, I have the honour to propose that the Agreement be again prolonged, as it stands, for a further period of six months, until the 27th of March, 1970.

3. If this proposal is acceptable to the Government of Paraguay I have the honour to suggest that Your Excellency's reply in that sense and this Note should be regarded as constituting an Agreement between the two Governments in this matter.

4. I avail myself of this opportunity to renew to Your Excellency the assurance of my highest consideration.

Tengo el honor de dirigirme a Vuestra Excelencia en ocasión de avisar el recibo de su nota N° 39 de fecha 27 de setiembre y cuyo texto es el siguiente:

“Excelencia: En fecha 31 de marzo, 1969, Vuestra Excelencia y yo efectuamos el cambio de Notas por la prolongación del Acuerdo entre el Gobierno del Reino Unido de Gran Bretaña e Irlanda del Norte y el

Paraguay sobre Comercio y Pagos en vigencia hasta el 27 de setiembre de 1969.—2. En vista de que esta fecha de vencimiento ya se cumple, y que las negociaciones para un nuevo Acuerdo no han concluído, tengo el honor de proponer que el Acuerdo sea prolongado en su forma existente por un período adicional de seis meses, hasta el 27 de marzo, 1970.—3. En caso de que esta propuesta es aceptable al Gobierno del Paraguay, tengo el honor de sugerir que la contestación de Vuestra Excelencia en este sentido y esta Nota en sí, sean considerados como constituyendo un Acuerdo entre los dos Gobiernos sobre esta cuestión.—4. Aprovecho esta oportunidad para reiterar a Vuestra Excelencia las seguridades de mi más alta y distinguida consideración.—FDO: B. C. MACDERMOT, Embajador ”.
