EXCHANGE OF NOTES

BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE REPUBLIC OF TURKEY AMENDING THE UNITED KINGDOM/TURKEY (STEEL PIPE PLANT) LOAN AGREEMENT No. 3. 1968. SIGNED AT ANKARA ON 22 MAY 1968

Your Excellency,

26 June, 1970.

I have the honour to refer to the discussions which have recently taken place between representatives of the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Republic of Turkey concerning the United Kingdom/Turkey (Steel Pipe Plant) Loan Agreement No. 3, 1968, constituted by the Exchange of Notes of the 22 May 1968 between the two Governments, (1) and to propose that:

- (1) The United Kingdom/Turkey (Steel Pipe Plant) Loan Agreement No. 3, 1968 shall be amended in the following respects:
 - (a) In Part A of the first paragraph of the United Kingdom Government's Note of 22 May 1968 the figures "£1,586,000" and the words "one million five hundred and eighty-six thousand pounds sterling" shall be deleted and replaced by the figures "£1,980,000" and the words "one million nine hundred and eighty thousand pounds sterling".
 - (b) In Part A of the first paragraph of the said Note after the words "Seamless Steel Pipe Plant" shall be inserted the words "including Kocks (UK) Stretch Reducing equipment".
 - (c) Part B(8) of the first paragraph of the said Note shall be amended in the following respects:
 - (i) The word "below" shall be deleted and replaced by the words "in the table of instalment repayments contained in Annex F to this Note"; and
 - (ii) the table of instalment repayments contained therein shall be deleted.
 - (d) The table of instalment repayments contained in Appendix A to this Note shall be inserted in the said Note of 22 May 1968, as Annex F.

(2) In view of these amendments the Government of the Republic of Turkey shall address a letter in the form set out at Appendix B to this Note to Barclays Bank Limited of 152-156 Upper Thames Street, London, E.C.4.

If the foregoing proposals are acceptable to the Government of the Republic of Turkey I have the honour to propose that the present Note together with Your Excellency's reply in that sense shall constitute an Agreement between the two Governments to amend the United Kingdom/Turkey (Steel Pipe Plant) Loan Agreement No. 3, 1968, which shall enter into force on the date of your reply.

I avail myself of this opportunity to renew to Your Excellency the assurance of my highest consideration.
