Monsieur le Ministre,

25 April 1972

I have the honour to refer to the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the French Republic, constituted by the Exchange of Notes that took place in Paris on 3 June 1964,(<sup>1</sup>) under which a Franco-British Commission of Surveillance was established for the geological survey in connection with the Channel Tunnel project.

That geological survey having now been successfully completed and the Commission of Surveillance having completed the discharge of its functions in relation thereto, I have the honour to propose that the Commission should now be dissolved and that this Note and Your Excellency's reply thereto accepting that proposal should together constitute an Agreement to that effect between our two Governments entering into force on the date of Your Excellency's reply.

I avail myself of this opportunity to renew to Your Excellency the assurances of my highest consideration.

J'ai l'honneur d'accuser réception de la lettre de Votre Excellence en date de ce jour, dont la traduction est la suivante:

"J'ai l'honneur de me référer à l'accord entre le Gouvernement de la République française et le Gouvernement du Royaume-Uni de Grande-Bretagne et d'Irlande du Nord constitué par l'échange de notes, qui a eu lieu à Paris le 3 juin 1964 et aux termes duquel une Commission de surveillance franco-britannique a été instituée en vue de l'étude géologique relative au projet de tunnel sous la Manche".
