## Excellency:

I have the honour to propose that the Memorandum of Understanding forming a part of the air charter services agreement between our two governments, effected by exchange of notes of March 30, 1973(1), as amended and extended by exchange of notes of March 29, 1974(2) and of April 2 and 3, 1975(3), as well as the related letter of March 29, 1974 from the Department of Trade and Industry regarding affinity charters, be further extended until December 31, 1975.

I have the further honour to propose that, if the Government of the United Kingdom of Great Britain and Northern Ireland accepts the foregoing proposal, this note and your reply to that effect shall constitute an agreement between our two governments in this matter, which shall enter into force on the date of your reply.
