BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE REPUBLIC OF INDONESIA AMENDING THE UNITED KINGDOM/INDONESIA LOAN AGREEMENT (No. 3) 1973 PROJECT DEVELOPMENT

Your Excellency,

I have the honour to refer to the Notes exchanged between our two Governments on the 13th of March, 1974, constituting the United Kingdom/Indonesia Loan Agreement (No. 3) Project Development, (1) and to inform you that the Government of the United Kingdom of Great Britain and Northern Ireland now declare that it is their intention to make available to the Government of Indonesia by way of interest-free loan an additional sum not exceeding £1.6 million for the purpose of development projects agreed during the period 1st of November, 1973, to the 30th of September, 1976.

I therefore have the honour to propose that the United Kingdom/Indonesia Loan Agreement (No. 3) 1973 Project Development be amended as follows:

- (a) In the first paragraph, Part A, the figures "£8,000,000" and the words "(eight million pounds sterling)" shall be deleted and replaced by "9,600,000" and "(nine million six hundred thousand pounds sterling)".
- (b) In the first paragraph, Part B (13), the figures "£222,300", "£222,300" and "£219,500" in the righthand column of the schedule shall be deleted and replaced by "£266,700", "£266,700" and "£265,500" respectively.

If the foregoing proposals are acceptable to the Government of Indonesia, I have the honour to suggest that the present Note and your reply to that effect shall constitute an Agreement between the two Governments to amend the United Kingdom/Indonesia Loan Agreement (No. 3) 1973 Project Development, which shall enter into force on the date of your reply.
