Your Excellency

I have the honour to refer to recent discussions between representatives of the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the United States of America concerning the Agreement constituted by the Exchange of Notes dated 30 December 1966 concerning the availability of the British Indian Ocean Territory islands for defence purposes(1) (hereinafter referred to as "the Agreement") and to propose that the Agreement be amended by deleting the following words in the opening paragraph:—

", and the islands of Aldabra, Farquhar and Desroches"

If the foregoing proposal is acceptable to the Government of the United States of America, I have the honour to propose that this Note and Your Excellency's reply to that effect shall constitute an Agreement between the two Governments to amend the agreement of 30 December 1966 with effect from 28 June 1976.
