EXCHANGE OF NOTES

BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE REPUBLIC OF UGANDA AMENDING AND EXTENDING THE OVERSEA'S SERVICE (UGANDA) AGREEMENT 1971

I have the honour to refer to discussions that have taken place between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Republic of Uganda relating to certain officers in the service of the Government of the Republic of Uganda designated by the Government of the United Kingdom under the provisions of the Overseas Service (Uganda) Agreement 1971(1) (hereinafter referred to as "the Agreement") which is due to terminate on 31 March 1976 and certain matters related to medical expenses and to place on record the terms that have been agreed:

- The Government of the United Kingdom will be prepared to continue the benefits under the Agreement as amended by sub-paragraph 2 of this Note after 31 March 1976 in respect of those officers specified by the Government of the United Kingdom in the Annex to the Agreement.
- 2. The amendments to the Agreement referred to in sub-paragraph 1 of this Note are as follows:—
 - (a) In line 6 of paragraph 1 after the words "United Kingdom" add the words "specified in the Annex to this Agreement".
 - (b) In sub-paragraph 1 of paragraph 1 after the words "or in respect of" add the word "designated" and after the words "Government of the Republic of Uganda" delete the words commencing from "or of officers" to the end of the sub-paragraph and substitute therefor the words "who are named in the Annex to this Agreement".

- (c) Delete in toto sub-paragraph 2 of paragraph 1.
- (d) In sub-paragraph 4 (b) of paragraph 1 delete the words "one-half of the aggregate" and substitute therefor the word "the"; after the words "the Government of the Republic of Uganda may, with the "add the word "prior". At the end of that sub-paragraph add a further sentence to read "Passages for designated officers and their dependent families should be, where available, by British carrier and where practicable by excursion or charter flight".
- (e) In sub-paragraph 5 (a) of paragraph 1 delete the words "An inducement allowance" and substitute therefor the words "A salary supplement".
- (f) In sub-paragraph 5 (d) of paragraph 1 delete the words "inducement allowance" and substitute therefor the words "salary supplement".
- (g) In sub-paragraph 13 of paragraph 1 delete the words and figures from "1st Day of April 1971" to the end of the paragraph and substitute therefor the words and figures "1 April 1976".
- (h) In sub-paragraph 14 of paragraph 1 delete the words and figures "31st March 1976" and substitute therefor the words and figures "31 March 1978".
- (i) Add an Annex to the Agreement containing the names of the following officers—

Mr. Justice P. A. P. J. Allen Mr. P. L. Beacham Miss M. D. Haden Mr. B. J. Kavanagh Mr. B. Remmer Miss D. Rowney Mr. J. B. Taylor Mr. J. L. P. Verley

If this Note correctly sets out the terms that have been agreed, I have the honour to propose that this Note and your reply shall constitute an Agreement between the Government of the United Kingdom and the Government of the Republic of Uganda which shall enter into force on 31 March 1976 and which shall be cited together with the Agreement as the Overseas Service (Uganda) (Continuance) Agreement 1971/76.
