**DECISION<sup>(1)</sup>**  
**OF THE REPRESENTATIVES OF THE GOVERNMENTS OF THE**  
**MEMBER STATES OF THE EUROPEAN COAL AND STEEL**  
**COMMUNITY, MEETING WITHIN THE COUNCIL OF**  
**18 JANUARY 1977 EXTENDING THE PERIOD OF VALIDITY**  
**OF DECISION 75/373/ECSC OPENING TARIFF PREFERENCES**  
**FOR PRODUCTS COVERED BY THAT COMMUNITY AND**  
**ORIGINATING IN ISRAEL**

The Representatives of the Governments of the Member States of the European Coal and Steel Community, meeting within the Council,

Whereas pending the entry into force of the Agreement between the Member States of the European Coal and Steel Community, of the one part, and the State of Israel, of the other part, signed on 11 May 1975<sup>(2)</sup>, the Representatives of the Governments of the Member States adopted autonomously and concomitantly Decision 75/373/ECSC opening tariff preferences for products covered by that Community and originating in Israel<sup>(3)</sup>; whereas that Decision was applicable until 30 June 1976 at the latest and was extended by Decision 76/567/ECSC<sup>(3)</sup> until 31 December 1976;

Whereas the said Agreement has not yet entered into force, and whereas the period of validity of the autonomous measures should be extended by six months, in agreement with the Commission,

Have decided as follows:

**ARTICLE 1**

In Article 4 of Decision 75/373/ECSC the date of 31 December 1976 is hereby replaced by that of 30 June 1977.

**ARTICLE 2**

Member States shall adopt all the measures necessary for the implementation of this Decision.
