DECISION(1)

OF THE REPRESENTATIVES OF THE GOVERNMENTS OF THE MEMBER STATES OF THE EUROPEAN COAL AND STEEL COMMUNITY, MEETING WITHIN THE COUNCIL, EXTENDING THE PERIOD OF VALIDITY OF DECISION 76/565/ECSC OPENING TARIFF PREFERENCES FOR PRODUCTS COVERED BY THAT COMMUNITY AND ORIGINATING IN ALGERIA

The Representatives of the Governments of the Member States of the European Coal and Steel Community, meeting within the Council,

Whereas, pending the entry into force of the Agreement between the Member States of the European Coal and Steel Community and the People's Democratic Republic of Algeria(2) signed on 26 April 1976 the Representatives of the Governments of the Member States adopted autonomously and concomitantly Decision 76/565/ECSC(3) opening tariff preferences for products covered by that Community and originating in Algeria, which is applicable until 30 June 1977 at the latest;

Whereas the said Agreement has not yet entered into force, and whereas the period of validity of the autonomous measures should be extended by one year;

In agreement with the Commission,

Have decided as follows:

ARTICLE 1

In Article 4 of Decision 76/565/ECSC, the date of "30 June 1977" is hereby relaced by "30 June 1978".

ARTICLE 2

Member States shall adopt all the measures necessary for the implementation of this Decision.
