**EXCHANGE OF NOTES**

**BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF  
GREAT BRITAIN AND NORTHERN IRELAND AND THE  
GOVERNMENT OF THE REPUBLIC OF COSTA RICA FURTHER  
AMENDING THE UNITED KINGDOM/COSTA RICA LOAN 1973**

Your Excellency:

I have the honour to refer to the exchange of Notes dated 15 February 1973<sup>(1)</sup> constituting the United Kingdom/Costa Rica Loan 1973 as amended by the exchange of Notes dated 30 September 1974,<sup>(2)</sup> and to propose the following further amendments thereto:

- (a) In Paragraph 1A, and in Annex A, the figures and words "£3,600,000 (three million six hundred thousand pounds sterling)" be deleted and the figures and words "£3,700,000 (three million seven hundred thousand pounds sterling)" be substituted; and
  - (b) The repayment schedule specified in paragraph 1B(8) and headed "Instalments" be deleted and replaced by the schedule specified in the Annex to this Note.
2. If the foregoing proposals are acceptable to the Government of Costa Rica I have the honour to propose that the present Note and its Annex together with your reply to that effect shall be known as the United Kingdom/Costa Rica Loan 1973 Amendment No. 2, and shall enter into force<sup>(3)</sup> on the date on which the Government of Costa Rica shall have notified the Government of the United Kingdom that the constitutional requirements of Costa Rica have been met.
3. I avail myself of this opportunity to renew to your Excellency the assurance of my highest consideration.

Señor Embajador:

Tengo el honor de contestar la nota de Vuestra Excelencia No. 58 de 25 de junio del año en curso, que dice:

“Excelencia: Tengo el honor de referirme al Intercambio de Notas fechado 15 de febrero de 1973 constituyendo el Préstamo Reino Unido/Costa Rica 1973, enmendado por el Intercambio de Notas fechado 30 de setiembre de 1974 y de proponer las siguientes enmiendas al mismo:

- (a) Que en el párrafo 1A y en el Anexo A se supriman los números y palabras “£3.600.000 (tres millones seiscientas mil libras esterlinas)” y que se inserten en su lugar los números y palabras “£3.700.000 (tres millones setecientos mil libras esterlinas)”; y
- (b) Que en el cuadro de reembolsas previsto en el párrafo 1B (8) intitulado “Abonos” se suprima y se sustituya por el cuadro que se adjunta a esta Nota.

2. Si el Gobierno de Costa Rica acepta las propuestas anteriores, tengo el honor de proponer que la presente Nota y su anexo, conjuntamente con la respuesta de Vuestra Excelencia a tal efecto, constituyan un Acuerdo sobre la materia entre los dos Gobiernos, el cual se denominará “Préstamo Reino Unido/Costa Rica 1973 Enmienda No. 2” y entrará en vigencia en la fecha en que el Gobierno de Costa Rica notifique al Gobierno del Reino Unido el haber cumplido con sus requisitos constitucionales.”

Me es grato comunicar a Vuestra Excelencia la aceptación del Gobierno de Costa Rica de las propuestas arriba transcritas.

En consecuencia, la presente nota y la de Vuestra Excelencia constituyen un acuerdo entre nuestras dos Gobiernos que se denominará "Préstamo Reino Unido/Costa Rica 1973 Enmienda No. 2", que entrará en vigor en la fecha en que comuniquemos el cumplimiento de nuestros requisitos constitucionales.

Aprovecho la oportunidad para renovarle las seguridades de mi distinguida consideración.
