EXCHANGE OF NOTES

BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF PAKISTAN AMENDING THE UNITED KINGDOM/PAKISTAN DEBT RELIEF AGREEMENT 1976 SIGNED AT ISLAMABAD, 27 NOVEMBER 1976

- 1. I have the honour to refer to your Government's Aide Memoire of 15 June 1977 and to the Exchange of Notes between the two Governments dated 27 November 1976 and known as the United Kingdom/Pakistan Debt Relief Agreement 1976(¹) (hereinafter called "the Agreement") and to inform you that, in accordance with the provisions of paragraph 10 of the Agreement, and in order to ensure that the amounts of relief received by the Government of Pakistan are in accordance with paragraph 3a of the Memorandum of Understanding on Debt Relief for Pakistan dated 28 June 1974, it is the intention of the Government of the United Kingdom to increase the percentage of relief to be provided to the Government of Pakistan in respect of the Pakistan financial year 1977/78 from 55% to 58%.
- 2. Accordingly I have the honour to propose the following amendments to the Agreement:

Paragraph 8: Delete the first sentence and substitute the following:

"The Government of the United Kingdom shall make funds available to the Government of Pakistan to the value of the relief due on the aid debt service payments and the relief due on the commercial debt service payments for the Pakistan financial years 1976/77 and 1977/78, in the following amounts and on the following dates:

Dates on which relief will be provided

Paragraph 8: Delete the last sentence and substitute the following:

"No repayment of relief already taken on aid debt servicing amounting to £5.808 million for 1974/75 and £7.492 million for 1975/76 nor repayment of the amounts of £6.117 million and £5.319 million to be made available as specified in this paragraph shall be made by the Government of Pakistan."

Annex 1

Delete and substitute the attached revised Annex.

- 3. If the foregoing proposals are acceptable to the Government of Pakistan I have the honour to suggest that the present note together with your reply in that sense shall constitute an Agreement between the Government of the United Kingdom and the Government of Pakistan which shall enter into force on the date of your reply.
- 4. I avail myself of the opportunity to renew to you, Sir, the assurance of my highest consideration.
