PROLONGING THE AGREEMENT FOR CO-OPERATION

Note No. 363

Her Britannic Majesty's Embassy in Budapest present their compliments to the Ministry of Foreign Affairs of the Hungarian People's Republic and have the honour to refer to the Agreement for Co-operation in the Field of Applied Science and Technology between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Hungarian People's Republic signed at Budapest on 9 August 1967⁽¹⁾, and to propose that, notwithstanding the provisions of Article VI thereof, the Agreement shall be deemed to have remained in force since 8 August 1977 and shall continue in force until 8 August 1982 and thereafter for further periods of five years unless either Contracting Government shall have given to the other Government written notice of termination not later than six months before 8 August 1982 or six months before the expiry of any subsequent period of five years.

If the foregoing proposal is acceptable to the Government of the Hungarian People's Republic, Her Britannic Majesty's Embassy have the honour to suggest that the present Note and the Ministry's reply in that sense shall constitute an Agreement between the two Governments which shall enter into force on the date of the Ministry's reply.

Her Britannic Majesty's Embassy avail themselves of this opportunity to renew to the Ministry of Foreign Affairs the assurances of their highest consideration.
