## **EXCHANGE OF NOTES**

AMENDING ARTICLE 2 OF THE BILATERAL AGREEMENT RELATING TO THE COLLECTION OF ROUTE CHARGES, SIGNED AT BRUSSELS ON 8 SEPTEMBER 1970, BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE EUROPEAN ORGANISATION FOR THE SAFETY OF AIR NAVIGATION (EUROCONTROL)

Your Excellency,

I have the honour to refer to the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the European Organisation for the Safety of Air Navigation (Eurocontrol) signed at Brussels on 8 September 1970(1), hereinafter called "the Bilateral Agreement". Discussions have taken place between the Organisation and your Government concerning the problem of recovering debts owed by aircraft operators to the Organisation.

Pursuant to the provisions of Article 5(2) of the Bilateral Agreement, and Article 12 of the "Eurocontrol" International Convention relating to Co-operation for the Safety of Air Navigation concluded at Brussels on 13 December  $1960(^{2})$ , I have the honour to propose that the following new sub-paragraph (c) be inserted in Article 2 of the Bilateral Agreement:

"(c) That the Organisation can have recourse to the United Kingdom authorities for the recovery of debts owed to the Organisation by the detention of aircraft on its behalf in accordance with the appropriate regulations of the United Kingdom of Great Britain and Northern Ireland".

If this proposal is acceptable to your Government I have the honour on behalf of the Organisation to propose that this Note, together with your reply in that sense, shall constitute an Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Organisation which shall, subject to the necessary amendment of United Kingdom legislation, enter into force on 1 January 1985(3).

I avail myself of this opportunity to renew to Your Excellency the assurances of my highest consideration
