Sir.

I have the honor to refer to the exchange of notes constituting an Agreement (hereinafter referred to as 'the Participation Agreement') between the United Kingdom of Great Britain and Northern Ireland and the Multinational Force and Observers (MFO), of 17 March and 21 April 1982(1), providing for the contribution of a headquarters company to the MFO. This Agreement set forth the terms and conditions of participation in the MFO, for a term of two years, extendable by mutual agreement. The United Kingdom's participation was so extended for an additional period of two years pursuant to an exchange of notes of 12 and 19 April 1984(2).

I have the further honor of proposing that the United Kingdom's participation in the MFO be continued for an additional period of one year commencing 21 April 1986, under the terms and conditions set forth in the Participation Agreement. This participation shall continue under the same terms and conditions for a further period of one year commencing on 21 April 1987, unless your Government informs the MFO at least 90 days prior to the expiry of the initial one year term of the United Kingdom's intention to terminate its participation. This participation may be further extended by agreement.

I wish to confirm in addition that the interpretative understandings related to the Participation Agreement, expressed in a separate exchange of notes of 17 and 21 April 1982(2), shall remain in effect during the additional period of participation.

If the foregoing is agreeable to the Government of the United Kingdom of Great Britain and Northern Ireland, I propose that this Note, together with your reply to that effect, shall constitute an Agreement on this subject which shall enter into force on the date of your reply.

I take this occasion to record our continuing appreciation for the important contribution that the United Kingdom contingent is making to the support of the peace.

Please accept the renewed assurances of my highest consideration.
