EXCHANGE OF NOTES BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE REPUBLIC OF BOLIVIA AMENDING THE UNITED KINGDOM/BOLIVIA LOAN (No. 1) 1973 (THE UNITED KINGDOM/BOLIVIA RETROSPECTIVE TERMS AGREEMENT 1992)

United Kingdom/Bolivia Retrospective Terms Agreement 1992

Your Excellency,

I have the honour to inform you that, following discussions between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Republic of Bolivia, it is the intention of my Government to provide assistance to your Government in accordance with the recommendations of the Trade and Development Board (TDB) UNCTAD. Retrospective adjustment shall be made available on the loan set out in Schedule 1 to this Note, which was provided as Official Development Assistance (ODA) and on which there was outstanding repayments of capital (hereinafter called "loan payments") on 1 June 1991.

The following paragraphs of this Note set out the nature of, and procedures for, the assistance to be given. For the purposes of this Note the eligible loan is that provided under the 1966 Overseas Aid Act [and other legislation] and set out in Schedule 1 to this Note. The amounts and phasing of such loan payments are set out in Schedule 2 to this Note.

Unless our Governments agree otherwise my Government shall waive all loan payments due on or after 1 June 1991, on the date that such payments fall due on the eligible loan.

The terms and conditions of the eligible loan shall otherwise continue to subsist.

Any loan payments due between 1 June 1991 and today's date inclusive and made by your Government on the eligible loan shall be refunded by my Government. Payment shall be made on receipt and approval by my Government of a request for payment as set out in Appendix A to this Note.

Loan payments due before 1 June 1991 but paid on or after that date shall not be refunded by my Government. Any loan payments due before 1 June 1991 and still outstanding shall be paid by your Government.

If these proposals are acceptable to the Government of the Republic of Bolivia I have the honour to suggest that the present Note together with your reply in that sense shall constitute an Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Republic of Bolivia in this matter which shall be known as the United Kingdom/Bolivia Retrospective Terms Agreement 1992 and which shall enter into force on the date of your reply.

I avail myself of this opportunity to renew to Your Excellency the assurance of my highest consideration.
