I have the honour to refer to the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the International Maritime Organization (previously known as the Inter-Governmental Maritime Consultative Organization) regarding the Headquarters of the Organization, signed at London on 28 November 1968¹ (hereinafter referred to as "the Agreement").

I now have the honour to propose the following amendments to the Agreement:

- (1) In Article 1(c) delete "Inter-Governmental Maritime Consultative Organization" and replace with "International Maritime Organization".
- (2) After Article 9 insert a new Article as follows:

Article 9 bis

"The Organization shall be accorded a refund of Insurance Premium Tax and Air Passenger Duty paid by the Organization in the exercise of its official activities."

- (3) In Article 10(1)(c) delete "municipal rates levied on" and insert "council tax payable in respect of".
- (4) In Article 10(4) delete "The municipal rates" and insert "The council tax".
- (5) In Article 13 bis (2)(a) delete "and municipal rates" and insert "including council tax".

If the foregoing proposals are acceptable to the International Maritime Organization, I have the honour to propose that this Note, together with your reply in that sense, shall constitute an Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the International Maritime Organization which shall enter into force on the date on which the United Kingdom legislation giving effect to the amendment comes into force.
