TO ANNEXES I AND II TO THE EUROPEAN
INTERIM AGREEMENTS ON SOCIAL SECURITY SIGNED AT PARIS
ON 11 DECEMBER 1953

The texts set out below should appear under the heading "Cyprus" to be added to the Annexes (1 December 1971 edition)⁽¹⁾ to the two Agreements on Social Security of 11 December 1953. The amendments were notified by the Secretary General of the Council of Europe on 8 May 1973 to all Member States, in accordance with Article 15 of the Agreements.

Annex I. Add section headed "Cyprus"

"Cyprus :

"Social Insurance Law and the Regulations made thereunder which establish a scheme providing benefits in respect of old age, invalidity and benefits payable to survivors (widow's pension and orphan's benefit).

"The scheme is of a contributory nature."

Annex II. Add section headed "Cyprus"

"Cyprus :

"Agreement on Social Insurance between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Republic of Cyprus dated 6 October, 1969."⁽³⁾

"Social Insurance Law and the Regulations made thereunder which establish a scheme providing unemployment benefit, sickness and maternity benefits (cash benefits), death grant and benefits in respect of personal injury by industrial accidents and prescribed diseases.

"The scheme is of a contributory nature."
