BY THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND, IN RESPECT OF THE UNITED KINGDOM AND CERTAIN OVERSEAS TERRITORIES, PROLONGING THE PERIOD OF RECOGNITION OR ACCEPTANCE OF THE COMPETENCE OF THE EUROPEAN COMMISSION OF HUMAN RIGHTS TO RECEIVE INDIVIDUAL PETITIONS; AND THE PERIOD OF RECOGNITION AS COMPULSORY OF THE JURISDICTION OF THE EUROPEAN COURT OF HUMAN RIGHTS

Letter No. 1

United Kingdom Permanent Representative to the Council of Europe, Strasbourg. 12 January, 1972.

Sir,

I have the honour to refer to Mr. Boothby's letters dated the 14th of January 1966(2) and the 11th of January 1969(3) which respectively declared the recognition by the Government of the United Kingdom of Great Britain and Northern Ireland, in respect of the United Kingdom, of the competence of the European Commission of Human Rights to receive petitions from persons, non-governmental organisations or groups of individuals, and prolonged, until the 13th of January 1972, the period of recognition or acceptance of the competence of the Commission in that respect.

On instructions from Her Majesty's Principal Secretary of State for Foreign and Commonwealth Affairs, I now have the honour to inform you that the Government of the United Kingdom hereby renew for the United Kingdom of Great Britain and Northern Ireland the declaration made in Mr. Boothby's letter of the 14th of January 1966, further prolonging the said period for a further two years, to end on the 13th of January 1974. Except in relation to the date of expiry of this period, the terms of the said declaration shall remain unaffected.
