M. le Secrétaire d'État,

SUR l'ordre du Conseil Fédéral Suisse, j'ai l'honneur d'informer votre Excellence que, par note du 17 Juin dernier, le Ministère des Affaires Étrangères du Nicaragua a annoncé à mon Gouvernement l'accession de cette République à la Convention de Genève pour l'amélioration du sort des blessés et malades dans les armées en campagne, du 6 Juillet, 1906.

Le Nicaragua ayant adhéré, en date du 28 Juin, 1898, à la Convention de Genève du 22 Août, 1864, son accession à la Convention du 6 Juillet, 1906, n'est subordonnée, à teneur de l'Article XXXII de cet Acte, à aucune autre condition.

*Swiss Legation, London, July 29, 1907.*

I HAVE the honour, by direction of the Swiss Federal Council, to inform your Excellency that, by a note dated the 17th June last, the Ministry of Foreign Affairs of Nicaragua announced to my Government the accession of that Republic to the Geneva Convention of 6th July, 1906, for the amelioration of the condition of the sick and wounded in armies in the field.

Nicaragua, having acceded on 28th June, 1898, to the Geneva Convention of 22nd August, 1864, its accession to the Convention of 6th July, 1906, is, in accordance with Article XXXII of the latter, subject to no other condition.
