AGREEMENT BETWEEN THE UNITED KINGDOM AND SIAM RESPECTING THE RENDITION OF FUGITIVE CRIMINALS BETWEEN CERTAIN STATES IN THE MALAY PENINSULA AND SIAM.

Signed at Bangkok, November 20, 1912.

THE Government of His Britannic Majesty and the Government of His Siamese Majesty, being desirous of regulating the rendition of fugitive criminals between certain States in the Malay Peninsula under the protection of His Britannic Majesty and the territories of His Majesty the King of Siam, hereby agree as follows:—

## ARTICLE 1.

The provisions of the Extradition Treaty between His Britannic Majesty and His Majesty the King of Siam, signed at Bangkok on the 4th day of March, 1911, shall be deemed to apply, so far as local circumstances permit, to the rendition of fugitive criminals between the territories of His Majesty the King of Siam and any State or States in the Malay Peninsula under the protection of His Britannic Majesty, the Ruler or Rulers of which shall, with the consent of the Contracting Parties, give notice of adhesion to it.

## ARTICLE 2.

In pursuance of the provisions of article 3 of the said Extradition Treaty there shall reciprocally be no obligation on the part of a Ruler of any such State to surrender to Siam any person who is his own subject, or a British subject, or a subject of any other State in the Malay Peninsula under the protection of His Britannic Majesty.

Done in duplicate at Bangkok, the 20th day of November, 1912, in the 131st Year of Ratana Kosindr.
