Sir, London, January 15, 1917. WITH reference to Viscount Grey of Fallodon's note of the 24th July, 1915, I have the honour to inform your Excellency that the Italian Government have decided to accede to the Convention concluded between Great Britain and France on the 9th November, 1914,* relating to naval prizes during the present European war, notwithstanding the interpretation which has been given by the British and French Governments to Article 2 of the Convention referred to in paragraphs 2 and 3 of the abovementioned note.

In requesting your Excellency to take note, in the name of the British Government, of the present declaration, I have the honour, &c.

I HAVE the honour to acknowledge the receipt of your Excellency's note of the 15th instant, in which you are good enough to inform me
