**EXCHANGE OF NOTES FURTHER PROLONGING THE MONETARY AGREEMENT OF 1st NOVEMBER, 1945, BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE CZECHOSLOVAK REPUBLIC**

Your Excellency,

*Foreign Office, 27th April, 1949.*

I HAVE the honour to propose that, in pursuance of arrangements discussed by Representatives of the two Governments in London, the Monetary Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Czechoslovak Republic signed in London on 1st November, 1945<sup>(1)</sup>, which in accordance with the exchange of notes dated 28th February and 2nd March<sup>(2)</sup> between Your Excellency and this Department will terminate on 4th May, 1949, unless the Contracting Governments agree otherwise, shall be further prolonged for a period of two months after the latter date, provided, however, that the provisions of sub-paragraph (a) of paragraph (i) of Article 2 of the said Agreement shall not apply during the proposed extended period.

2. If the Czechoslovak Government agree to this proposal I have the honour to suggest that the present Note and your reply to that effect shall be regarded as constituting an agreement between the two Governments.

Majesty's Foreign Office will terminate on 4th May, 1949, unless the Contracting Governments agree otherwise, shall be prolonged for a period of two months after the latter date provided, however, that the provisions of subparagraph (a) of paragraph (i) of Article 2 of the said Agreement shall not apply during the proposed extended period.

In reply, I have the honour to inform you that the Government of the Czechoslovak Republic accept this proposal of the Government of the United Kingdom and will regard your Note and this reply as constituting an agreement between the two Governments.
