Sir,

London, January 7, 1952. I have the honor to refer to the Agreement between our two Governments on Technical Assistance for Eritrea signed in London on the 15th June, 1951(1), and to inform you that the provisions of the Mutual Security Act of 1951, Public Law 165, (Section 511 (b)), enacted by the 82nd Congress of the United States, would prevent the United States Government from continuing the program of technical assistance to Eritrea unless the Government of the United Kingdom of Great Britain and Northern Ireland will agree in their capacity as the Administering Power for Eritrea to join in promoting international understanding and good will and in maintaining world peace, and to undertake such action as may be agreed with the United States Government to eliminate causes of international tension.

Sir,

I have the honour to acknowledge your Note of to-day, which states:—

I have the honour to inform you that the Government of the United Kingdom of Great Britain and Northern Ireland agree, in their capacity as the Administering Power for Eritrea during the transition period and so far as it is possible for them to do so having regard to the Resolution adopted by the General Assembly of the United Nations on the 2nd December, 1950, (No. 390/V), to join in promoting international understanding and good will and in maintaining world peace, and to undertake such action as may be agreed with the United States Government to eliminate causes of international tension.

I have the honour to propose that the undertaking given in the preceding paragraph should be considered as forming an integral part of the Agreement of the 15th June, 1951, and that your Note, my present Note, and your reply should constitute an agreement between our two Governments in this matter.
