EXCHANGE OF NOTES

BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE REPUBLIC OF TURKEY AMENDING THE UNITED KINGDOM/TURKEY (BOSPHORUS BRIDGE) LOAN AGREEMENT 1970 SIGNED AT ANKARA ON 7 APRIL 1970

The British Chargé d'Affaires ad interim at Ankara to the Secretary-General, Department of the Treasury and Organisation for Industrial Economic Co-operation, Ministry of Finance of Turkey

Your Excellency,

12 November, 1970.

I have the honour to refer to the United Kingdom/Turkey (Bosphorus Bridge) Loan Agreement 1970(1) constituted by the Exchange of Notes of the 7th April, 1970, between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Republic of Turkey and to propose that the Agreement be amended as follows:

- (a) to Part B (3) add:
 - "(c) for reimbursing the Government of Turkey the sterling cost, up to a maximum of the equivalent of \$30,000, of the United Kingdom member of the Board of Consultants established by the Turkish authorities to advise on technical matters concerning the Project in its various stages."
- (b) in Part B (6) delete the words "paragraph (3) (b) refers" and substitute the words "paragraphs (3) (b) and (3) (c) refer";
- (c) to Part B (6) (d) add:
 - "(vii) the sterling cost, up to a maximum of the equivalent of \$30,000, of the United Kingdom member of the Board of Consultants."
- 2. If the foregoing is acceptable to the Government of the Republic of Turkey, I have the honour to propose that the present Note together with Your Excellency's reply to that effect shall constitute an Agreement between the two Governments in this matter, which shall enter into force on the date of your reply.

I avail myself of this opportunity to renew to Your Excellency the assurances of my highest consideration.
