Your Excellency,

22 May 1971.

I have the honour to refer to the United Kingdom/Afghanistan Loan Agreement 1970, constituted by the Exchange of Notes of 13 December 1970 between the Government of the United Kingdom of Great Britain and Northern Ireland and the Royal Afghan Government,(1) and to propose that the Agreement be amended as follows:

- (a) In sub-paragraph (1) the figures "£77,000" and the words "(seventy-seven thousand pounds sterling)" shall be deleted and replaced by "£131,000" and "(one hundred and thirty one thousand pounds sterling)".
- (b) In sub-paragraph (5) the schedule of instalments shall be deleted and replaced by the following:
