# BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE HASHEMITE KINGDOM OF JORDAN AMENDING THE UNITED KINGDOM/JORDAN DEVELOPMENT LOAN 1973

Your Excellency

20 March 1976

- 1. I have the honour to refer to the United Kingdom/Jordan Development Loan 1973 constituted by Notes exchanged at Amman on 11 and 14 June 1973 (hereinafter referred to as "the Development Loan 1973"),(1) and to recent discussions concerning the allocation of additional funds from the Government of the United Kingdom of Great Britain and Northern Ireland to the Government of the Hashemite Kingdom of Jordan to assist the latter to meet the increased costs of certain development projects financed from the Development Loan 1973.
- 2. I now write to inform Your Excellency that it is the intention of the Government of the United Kingdom to make available to the Government of Jordan an additional sum not exceeding £701,000 (seven hundred and one thousand pounds sterling), which sum shall be subject to the same arrangements and procedures as those specified in the Development Loan 1973, as amended in paragraph (3) below.
- 3. To take account of this additional sum, I have the honour to propose that the repayment schedule in paragraph B (10) of the Development Loan 1973 be amended as follows:

14 December 1980 and on 14 December in each of the succeeding 17 years 14 June 1981 and on 14 June in each of the	297,250

- 4. If the foregoing is acceptable to the Government of the Hashemite Kingdom of Jordan, I have the honour to propose that this Note, together with your Excellency's reply in that sense, shall constitute an Agreement between the two Governments which shall enter into force on the date of Your Excellency's reply. This Agreement together with the Development Loan 1973 shall be referred to as the United Kingdom/Jordan Development Loan 1973/1976.
- 5. Please accept, Your Excellency, the assurances of my highest consideration.
