Your Excellency,

I have the honour to refer to the United Kingdom/Peru No. 1 Loan Agreement 1973⁽¹⁾ and to propose the following amendments thereto:

(a) In paragraph 1A, and in paragraph 1 of Annex A, the figures and words "£390,000 (three hundred and ninety thousand pounds sterling)" be deleted and the figures and words "£450,000 (four hundred and fifty thousand pounds sterling)" be substituted;

(b) The repayment schedule specified in subparagraph 8 of paragraph 1B and headed "Instalments" be deleted and replaced by the schedule specified in the Annex to this Note; and

(c) In subparagraph 5(c) of paragraph 1B the figures and words "30 June 1975" be deleted and the figures and words "31 March 1976" be substituted thereafter.

If the foregoing proposals are acceptable to the Government of the Republic of Peru, I have the honour to propose that the present Note and its Annex together with Your Excellency's reply in that sense shall constitute an agreement between our two Governments which shall be deemed to have entered into force on 18 August 1975 and which shall be known as the United Kingdom/Peru No. 1 Loan Agreement 1973 Amendment No. 1.

I avail myself of this opportunity to renew to your Excellency the assurance of my highest consideration.

Señor Encargado de Negocios a.i.:

Me es grato dirigirme a Vuestra Excelencia en relación a su atenta Nota, de fecha 12 de julio de 1976, redactada en los siguientes términos:

“Tengo el honor de referirme al Acuerdo de Préstamo Reino Unido/ Perú No. 1 1973 y de proponer las siguientes enmiendas: (a) En el párrafo 1A, y en el párrafo 1 del Anexo A, los números y palabras “L.E.390,000 (trescientas noventa mil libras esterlinas)” sean suprimidas y sustituidas por los números y palabras “L.E.450,000 (cuatrocientas cincuenta mil libras esterlinas)”; (b) El calendario de pagos especificado en el subpárrafo 8 del párrafo 1B y titulado “Armadas” sea suprimido y sustituido por el cuadro en el Anexo a esta Nota; y (c) En el subpárrafo 5(c) del párrafo 1B los números y palabras “30 de junio de 1975” deben ser suprimidos y sustituidos por los números y palabras “31 de marzo de 1976”. Si las propuestas que anteceden son aceptables al Gobierno del Perú, tengo el honor de proponer que la presente Nota y su Anexo conjuntamente con la respuesta de Su Excelencia en tal sentido constituyen un acuerdo entre nuestros dos Gobiernos el que se estima que haya entrado en vigencia el 18 de agosto de 1975 y el cual será conocido como Acuerdo de Préstamo Reino Unido Perú No. 1/1973, Enmienda No. 1. Hago propicia esta oportunidad para renovar a Vuestra Excelencia las seguridades de mi más alta consideración.
