AMENDMENT¹ TO THE STATUTE OF THE COUNCIL OF EUROPE CERTIFICATE OF THE SECRETARY GENERAL

(Article 41, Paragraph d, of the Statute)

Certificate of the Secretary General of the Council of Europe

Whereas paragraph d of Article 41 of the Statute of the Council of Europe provides that amendments to Articles 23–35, 38 and 39 which have been approved by the Committee of Ministers and the Consultative Assembly shall come into force on the date of the certificate of the Secretary General, transmitted to the governments of members, certifying that they have been so approved,

The Secretary General hereby certifies as follows:

- 1. The Committee of Ministers, by the adoption on 13 May 1993, of Resolutions (93) 23, (93) 24, (93) 25, fixing respectively the number of Representatives of Estonia, of Lithuania and of Slovenia in the Consultative Assembly, approved the amendments to Article 26 of the Statute, the text of which is set out below;
- 2. The Consultative Assembly approved the same amendments on 11, 12 and 13 May 1993 (Opinions Nos. 168, 169, 170 (1993));
- 3. Both organs of the Council of Europe having thus approved them, the amendments come into force this 14th day of May 1993, being the date of this certificate, transmitted on the same date to the governments of members.

The amended text of Article 26 is worded as follows:

"Members shall be entitled to the number of Representatives given below:
