**AMENDMENT<sup>1</sup>**  
**TO ANNEX III<sup>1</sup> OF THE CONVENTION ON THE PREVENTION**  
**OF MARINE POLLUTION BY DUMPING OF WASTES**  
**AND OTHER MATTER<sup>2</sup>**

The following text should be included in Annex III Section A:

“9. In issuing a permit for dumping, Contracting Parties should consider whether an adequate scientific basis exists concerning characteristics and composition of the matter to be dumped to assess the impact of the matter on marine life and on human health.”,

<sup>1</sup>This amendment was adopted at the Twelfth Consultative meeting of Contracting Parties by LDC Resolution 37(12) on 3 November 1989 at which time it was resolved that for the purposes of Articles XIV(4)(a) and XV(2) of the Convention, 8 February 1990 shall be treated as the date of the approval of the amendment. In accordance with the terms of the resolution and article XV(2) of the Convention the amendment entered into force on 19 May 1990 for all Contracting Parties.

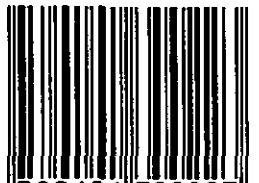
