M. Carlin to the Marquess of Lansdowne.—(Received June 30.)

M. le Marquis,

Londres, le 29 Juin, 1903.

SUR l'ordre de mon Gouvernement, j'ai l'honneur d'informer votre Seigneurie que, par note du 13 courant, son Excellence M. Deuntzer, Président du Conseil, Ministre des Affaires Étrangères du Royaume de Danemark, a fait connaître au Conseil Fédéral l'adhésion de ce Royaume à la Convention du 9 Septembre, 1886, créant une Union pour la protection des œuvres littéraires et artistiques, ainsi qu'à l'Article Additionnel et à la Déclaration interprétative signés à Paris le 4 Mai, 1896.

Cette adhésion produira ses effets à partir du 1^{er} Juillet prochain, et comprendra le Royaume de Danemark et les Iles Féroë, avec exclusion de l'Islande, du Groenland, et des Antilles Danoises.

En ce qui concerne la contribution aux dépenses du Bureau International de Berne, le Danemark sera rangé dans la quatrième classe.

Je vous serais fort obligé de vouloir bien consentir à me donner acte de la présente communication, et saisis, &c.

London, June 29, 1903.

By direction of my Government I have the honour to inform your Lordship that, by a note dated the 13th of this month, his Excellency M. Deuntzer, President of the Council, Minister for Foreign Affairs of the Kingdom of Denmark, notified to the Federal Council the accession of that Kingdom to the Convention of the 9th September, 1886, establishing a Union for the protection of literary and artistic works, as well as to the Additional Article and explanatory Declaration signed at Paris on the 4th May, 1896.

This accession will take effect from the 1st July next, and will include the Kingdom of Denmark and the Farøe Islands, but will exclude Iceland, Greenland, and the Danish Antilles.

As regards its contribution to the expenses of the Berne International Bureau, Denmark will be placed in the fourth class.

I shall be much obliged if you will be so good as to take note of this communication, and I avail, &c.

I HAVE the honour to acknowledge the receipt of your note of the 29th ultimo, notifying the accession of Denmark to the Convention of the 9th September, 1886, for the protection of literary and artistic works, and also to the Additional Article and Declaration of the 4th May, 1896.

His Majesty's Government note that the accession will take effect from the 1st instant, and will include the Kingdom of Denmark and the Farøe Islands, but will exclude Iceland, Greenland, and the Danish Antilles; and also that, as regards its contribution to the expenses of the Berne Bureau, Denmark will be placed in the fourth class.
